(1) Payments: No payments this month.

## **MIN 32/21 CORRESPONDENCE**

(1) Report from Quarry Liaison Meeting: Despite chasing the quarry neither Cllr. M. Jones or the Clerk had been able to get a response re. the planned July meeting. Cllr. M. Jones had now managed to speak to someone at the quarry and had been told that that the Manager concerned was off work. It was agreed that the Clerk contact Mr. M. Lawer to ask that the meeting be re-arranged for the Autumn and a date agreed as soon as possible.

(2) Publication of Draft Minutes – Requirement to publish key facts/decisions in Local Government (Wales) Act: The Clerk explained the need to publish details of key decisions within seven working days of each meeting and suggested that the publication of draft Minutes would fit these criteria. Members agreed that the Clerk publish draft Minutes as soon as possible after each meeting.

- (3) Police and Crime Commissioner Survey: Resolved no comment be made.
- (4) Willin Brook: Members confirmed no work had yet been done. The Clerk would chase it up with the County Council.
- (5) Welsh Government Consultation launch 28 June 2021: - Consultation on Qualifications of Clerks in Wales Regulations: The Clerk explained the reasons for the consultation and the qualifications proposed. Members were happy with proposals and asked that the Clerk submit the additional comment that a qualified clerk was very important to the proper conduct of all Council business not just for the use of the general power of competence.
